Need to know

Entry requirements

You are required to have a minimum of 12 months experience owning and or managing a business and will be subject to a selection criteria ensuring that you have a suitable background and experience to participate in this program. Contact us on **1300 40 60 80** to book your free consultation.

Resources required

No specific resources are required to successfully complete this course. It is recommended that you have a reliable internet connection to access TAFE Queensland's online learning system Connect, and a computer with up-to-date software, including Microsoft Office, Adobe Acrobat Reader and Adobe Flash Player. Payment options

Higher level skills subsidy

\$500

To be eligible for the subsidised program funded by the Queensland Government:

- be 15 years or older and no longer in school
- reside in Queensland
- be an Australian or New Zealand citizen or permanent resident or an owner, manager or employee of a small business in Queensland
- supply an Australian Business Number (ABN) along with supporting evidence
- have not obtained or been enrolled in a certificate IV or above qualification previously.

Full fee

\$2,600

This is the total cost of the program.

Concession

\$60

To be eligible for concession, you must meet the eligibility criteria for the Higher Level Skills subsidy, as well as one of the following:

- be Aboriginal or Torres Strait Islander
- have a current Centrelink Pensioner
- hold a Concession Card, Health Care Card or a Department of Veterans' Affairs Card
- hold a current Pensioner Concession Card.

Payment plans available

TAFE Queensland offers payment plans* so you don't have to pay the lump sum fee when you enrol; instead, made over six fortnightly instalments.

*Payment plans only apply to full fee and Higher Level Skill subsidy amounts.
